WHAT DO WE OFFER?

Social counselling:

We provide every client with support and information according to his or her individual needs and also possibilities of our organization, particularly in the following areas:

- Information regarding the type of his or her stay or residence
- Education
- Social Security
- Health care
- Family matters (marriage, child birth, reuniting of the families,...)
- Obtaining the Czech citizenship
- Mediating the follow-up and other related services, providing contact information
- Assistance in dealing with the authorities

Employment counselling:

- Help with writing CV
- Orientation in job offers
- In case of a language barrier help with contacting of an employer
- Preparation for an interview
- Information about the work contract, formal requirements before starting, rights and obligations (duties) of an employee and an employer

Czech language classes:

- We offer drop-in classes in Czech language, which are open to every foreigner
- The goal of the classes is to obtain basic communication skills in Czech language

WHO ARE OUR CLIENTS?

Our clients are foreigners with legal stay in the Czech Republic (long-term stay, time-limited stay as family members, permanent residence,...); basic information are provided to all foreigners regardless of the type of stay.

OUR MISSION

Centre for the Integration of Foreigners (CIC) is a civic association which helps foreigners with the integration into the Czech society. The mission of one of our programs – social counselling – is to help the immigrants who have been put at risk by their disadvantageous social situation.

THE GOAL OF SOCIAL COUNSELLING of CIC

The goal of social counselling is to help immigrants to become independent, self-reliant and equal members of the society, who would manage to secure both their essential needs and a dignified standard of living, and fulfilment and welfare in the Czech Republic.

MAIN PRINCIPLES OF OUR WORK

Social and employment counselling and informational seminars are **free of charge**

- We respect the individuality of every human being (client or person interested in CIC services) and his or her perception of his or her own situation in the Czech Republic. We approach every person equally, regardless of his or her origin, age, handicap, etc.
- We encourage and lead the client towards his or her independent decision making and individual responsibility.
- We do not give any information to the third parties – data, personal or other information, that are a subject of cooperation between a client and a social worker. This information cannot be passed on to a third party with prior consent of a client, where applicable. (The only exception are law requirements). We do not involve a third party (authorities, employers,...) without the client's permission.
